Operations Manager

Reporting to the Director of Fleet Operations, the **Operations Manager** will be responsible for the day-to-day operations and management of Ocean Choice's new groundfish vessel.

Duties and responsibilities include:

- Development and implementation of effective vessel management strategies that will include but not limited to efficient turnaround schedules and fishing plan activity;
- Preventative maintenance oversight including the coordination of activities with vessel crew and maintenance supervisors;
- Responsible for monitoring the production input, hail and pack mix to ensure it meets Ocean Choice specification and standards;
- Plan and review production operations to ascertain product data such as types, quality, quantities and specifications of products meets company specifications;
- Reviews production and operating reports and resolves operational, manufacturing, and maintenance problems to ensure minimum costs and prevent operational delays;
- Responsible for coordinating the adherence to the safety requirements of Federal and Provincial legislation as well as corporate objectives;
- Responsible for the implementation, preparation and review of monthly vessel reports;
- Overseeing and verification of onboard Quality Control program reports. Liaison with Canadian Food Inspection Agency (CFIA) as well as the companies Quality Assurance and Control Department to ensure food safety programs are adhered to and in compliance.
- Ensuring the vessel operates efficiently following Ocean Choice work safe and Transport Canada rules and regulations;

As a key member of our team, you will lead a number of projects to contribute to the development and implementation of new operational systems and processes to support and drive the Fleet Operations Group. Candidates should have strong analytical skills with proven problem solving ability. You will assess current business practices and design as well as develop solutions to meet the requirements of the Group.
